5. After due scrutiny of the documents and payment confirmation of 1st year tuition fees provisional admission letter will be issued to the student on the day of counseling. Student is expected to act as per directions mentioned on the provisional admission letter. Without payment of 1st year tuition fees in full admission will not be granted and such student will not have any claim for admission later on.
6. The Candidate has to pay **Annual Tuition Fees** of first year **BPT/B.Sc. Nursing/BPO** programme through their **online application form login portal** immediately after the

admission counseling on receipt of provisional admission letter. Please note that **No other mode of payment will be accepted.**
